## 12. Concentration by Interterence Optics :

Consider a centrifuge double sector cell with protein solution on the sample side and dilute buffer on the reference side that has a hairline crack between the two sectors so that the buffer can layer over the protein solution once the centrifuge is turned on. For this experiment, the $\mathrm{T}=20^{\circ} \mathrm{C}$, the rotor speed $\omega=4250 \mathrm{rpm}$, the radius to the sample optics section is 6.66 cm , the cell path length to be $12.00 \mathrm{~mm}, \lambda=546 \mathrm{~nm}$, and $\left(\mathrm{dn} / \mathrm{dc}=0.186\left(\mathrm{~g} / \mathrm{cm}^{3}\right)^{-1}\right.$. Using interference optics to monitor the run, the results shown below are obtained where $\mathrm{a}=4.54 \mathrm{~mm}, \mathrm{~b}=5.61 \mathrm{~mm}, \mathrm{c}=6.65 \mathrm{~mm}, \mathrm{~d}=7.72$ $\mathrm{mm}, \mathrm{e}=8.79 \mathrm{~mm}$ and $\mathrm{h}=8.46 \mathrm{~mm}$.

13. In a sedimentation equilibrium experiment, a protein is centrifuged at 7200 rpm . The temperature of the system is maintained constant at $20^{\circ} \mathrm{C}$ and the density of the colloid is 1.25 $\mathrm{kg} / \mathrm{L}$ and it is known that 1.00 g of sediment displaces 0.742 mL of water and that the density of the dilute solvent is $1.00 \mathrm{~g} / \mathrm{mL}$.
